I am responsible for paying any and all fees not covered by my financial aid.

I understand that my financial aid will be reduced/canceled if my enrollment changes. (A student is not eligible for financial aid if enrollment drops below 6 units for undergraduates and 5 units for graduates.) I will be required to repay any financial aid I received if my enrollment for summer drops below half time.

You will not be awarded aid until your enrollment at the host UC campus is confirmed.
